The Regent Family looks forward to welcoming you aboard soon. As you prepare for your journey, we would like to inform you of the following itinerary updates to your cruise sailing from Athens to Miami.

Regarding your itinerary, at this time transit from Turkey to Italy is not allowed per the Italian government. Considering this restriction, in addition to the Italian protocols that only enable guests to disembark on Regent sponsored shore excursions, Regent made the difficult decision to replace the Italian ports of call.

The revised day-by-day itinerary can be found below. Shore excursions for the newly-added ports will be open for reservations by November 1, 2021.

Required COVID-19 Testing During Cruise

All guests will be required to take a COVID-19 antigen test and receive a negative test result to disembark the ship at the end of the cruise. Additional antigen tests may be required by one or more of the ports along the way. These tests will be administered onboard the ship and will be paid for by Regent Seven Seas Cruises.

Pre-Cruise Check List for Arrival Country and Embarkation Requirements

Before you begin your journey please be sure to complete the below country specific health declarations at home and bring the completed documentation with you to the ship.

1) Greece Entry Requirements

All guests are required to complete Greece's Passenger Locator Form (PLF).

2) France Entry Requirements

Applying for a French COVID Pass for Non-European Foreigners

All guests are required to present a French COVID Pass when entering the majority of public places in France, including restaurants, cafés, cinemas, museums, and theatres. A French COVID Pass "converts" your local proof of vaccination into a QR code that allows you into these public places. These documents can be shown in paper format, digitally, or through the phone application TousAntiCovid.

- The below documents will be needed to complete the application:
 - A photo of your passport.
 - o A scan or photo of your vaccination card.
 - Final cruise vacation summary PDF, which includes the cruise itinerary. We will email you an updated PDF over the next few days.

3) **Spain Entry Requirements**

- All travelers must complete Spain's Health Control Form 48 hours prior to arrival in Spain and present upon arrival the QR code generated in this form, which must be printed or on your mobile phone.
- Please <u>CLICK HERE</u> for instructions on completing Spain's Health Control Form when arriving by cruise ship.
- Vaccinated travelers must present a certificate of vaccination on arrival.
 Acceptable vaccines are those approved by the EMA or the WHO (Pfizer-BioNTech, Moderna, AstraZeneca, Janssen, Sinopharm, and Sinovac-CoronaVac). Travelers must prove receipt of the final dose at least 14 days before entry.

Current Destination Requirements

Throughout your journey there will be requirements to visit specific destinations. Below please find these destination specific requirements, which are subject to change.

Athens (Piraeus), Greece

- Guests must carry their proof of vaccination.
- Guests are required to complete and bring Greece's Passenger Locator Form in paper format or digitally when going ashore.
- Guests can go ashore independently.

Mytilini (Lesbos), Greece

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.
- Guests are required to bring their completed Passenger Locator Form in paper format or digitally when going ashore.

Istanbul, Turkey

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.

Ephesus (Kusadasi), Turkey

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.

Corfu, Greece

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.
- Guests are required to bring their completed Passenger Locator Form in paper format or digitally when going ashore.

Dubrovnik, Croatia

- Face coverings are required in all indoor spaces and on all transportation.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.

Nice (Villefranche), France

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.
- To enter the majority of public places, including restaurants, cafés, cinemas, museums, and theatres, guests are required to complete French COVID Pass for Non-European Foreigners. The QR code must be shown in paper format or digitally.

Toulon, France

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.
- To enter the majority of public places, including restaurants, cafés, cinemas, museums, and theatres, guests are required to complete French COVID Pass for Non-European Foreigners. The QR code must be shown in paper format or digitally.

Barcelona, Spain

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.

Arrecife (Lanzarote), Canary Islands, Spain

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.

Santa Cruz de Tenerife, Canary Islands, Spain

- Guests must carry their proof of vaccination.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.

San Juan, Puerto Rico

- Guests must carry their proof of vaccination.
- All guests must undergo a health clearance upon arrival.
- Guests can go ashore independently or on shore excursions organized by Regent Seven Seas Cruises.

Miami, Florida

- All guests will be required to take a COVID-19 antigen test and receive a negative test result to disembark the ship at the end of the cruise. This test will be administered onboard the ship on December 6th and will be paid for by Regent Seven Seas Cruises.
 - If a PCR test is required for any travel home, a PCR test will be administered onboard and paid for by Regent Seven Seas Cruises, only for those guests whose home country specifically requires a PCR test.
